Herewith we transfer the approval as "BMW Longlife-04" oil, given for engine oil code  
to the oil "TITAN GT1 FLEX 3", SAE 5W-40  
of FUCHS PETROLUB SE. Consequently it is approved according to our release  
procedure for BMW Longlife engine oils (9<sup>th</sup> edition, November 2018) for the usage in BMW  
engines operating in compliance with our operating fluids manual.

This confirmation is valid for two years beginning with the date of this letter (provided that the  
reference formulation is still approved) and can be extended no more than two times for a maximum  
of two years in each case. Prolongations have to be requested within BFAS (BMW Fluid Approval  
System), the extension date can be taken from BFAS, reference EOA-RBL-2020-01881.

Engine oils produced using the code or brand names mentioned in this letter of confirmation have  
to comply with the tested oil sample in every respect. Any proposed alteration or modification to  
the lubricant has to be supplied in writing to the BMW department "Entwicklung Antrieb" whereby  
a new approval may be granted.
